### PA UCC PERMITS

*\$4.50 Training Fee will be added to each Construction/Demolition and Plumbing Permit, respectively for remittance to the Department of Labor and Industry, as mandated by Pennsylvania State Law.*

*\*FAILURE TO OBTAIN THE NECESSARY PERMIT(S) SHALL RESULT IN PERMIT FEE(S) BEING DOUBLED. PERMIT FEES INCLUDE ALL INSPECTIONS REQUIRED FOR PROJECT CODE COMPLIANCE. IF MORE THAN ONE RE-INSPECTION IS REQUIRED FOR A FAILED INSPECTION, A RE-INSPECTION FEE OF \$32.00 SHALL BE PAID TO THE TOWNSHIP PRIOR TO THE INSPECTOR COMING BACK TO THE JOBSITE TO PERFORM THE REQUIRED INSPECTION. PERMIT FEES DO NOT INCLUDE CONSULTING IN WHICH AN INSPECTOR/PLAN REVIEWER IS REQUESTED FOR A MEETING. IF A MEETING IS REQUESTED FOR A PROJECT, A FEE OF \$32.00 PER 1/2 HOUR WILL BE ADDED TO THE PERMIT FEE OR BILLED DIRECTLY TO THE APPLICANT/OWNER. NO INSPECTIONS WILL BE PERFORMED UNTIL SUCH PAYMENT IS MADE TO PERKIOMEN TOWNSHIP.*
